PY&SF Undertakes History Projects "Parker Families of Yakima and YVCC"

The historical committee has taken on two ambitious projects involving the namesake of the PY&SF and the history of Yakima Valley Community College. Jerry Ward, chair of the committee is taking a good deal of ribbing as to his deadline of 2028 when the college will celebrate its 100th Anniversary and counters with the comment that "we aren't getting any younger" and now is the time to check those memory banks, files, yearbooks, and picture albums for material that can be used in the story. However, the Parker family project, though on going, has a more reasonable deadline for stories about the roots of our Foundation. We continue to find new information about the Parker ancestors that probably has not been discussed or known for many years and even then probably shared only with the immediate Parker family. We hope to start a High Hopes series of columns about the Parkers in the next edition. The YVCC project will be in the "collection" stage with a possible preview story for the college's 90th anniversary in two years. The committee is always looking for new contacts, information and pictures that link to the Parker family as well as YVCC.

After the passing of Daryl Parker in March of 2015, Sherrie Parker loaned the Foundation several files about the family, not the least of which was a family bible from the late 1800's with recorded marriages, births, and death dates. Also, a priceless copy of a diary by Armeda Lesh Parker. Armeda was Daryl Parkers great grandmother and the diary covers the two month wagon train trip of the Parker family when they migrated to the Yakima Valley from Pawnee City, Nebraska, in 1878. These Parker files are further defining how involved this family was in the "pioneer" days of early Yakima, ranging from planting the "first" orchard to the first Superintendent of schools in 1883. The files cover the marriage of Rose Parker to A. E. Larson and further substantiate their involvement with the development of Yakima Valley College. The Parker-Larson family provided Yakima with the land for Parker-Faller Field, Larson Park and Gallery and, of course, the land the college occupies.

The current and new benefit for our historical committee is working with Niki Hopkins, Coordinator of Community Relations at YVCC. Her office has every Commencement Program on file since the first ceremony in 1930. We are entering information from these programs that will give us a year by year record of commencement speakers, Board members, student and award recipients and more. Once this data entry is completed, our committee will meet with a range of students, faculty, staff, and alumni as to what type of narrative could be written for each year. Thanks to former Parker Partner Connie Little, a true valley historian,

we have a copy of "Our Yesterdays". This 300 page manuscript includes a 30 page section about Yakima Junior College from 1928 to 1956 and was written by R. R. Glenn and Harold Hoeglund. The committee is not sitting around drawing straws as to who "will" be assigned to cover the 100th anniversary of the college, but we are confident that a record will be in place as to a starting point to produce a history of "old" Yakima Junior College, a history that obviously includes the Parker and Larson family support and involvement.

WIAA Hall of Fame, 2011 Virginia Hays, Official

Virginia Hays has been involved with officiating in the state of Washington for 39 years as a member of the board of officials, a clinician, and as an officials coordinator for state tournaments. Her love for sports carried with her throughout college where she graduated from Western Washington State College. She graduated in 1971 with a Bachelor of Education in K-12 Physical and Health Education. While at Western she lettered in volleyball, field hockey, basketball and softball. After college she went on to Washington State University where she received her graduate degree.

Virginia started officiating volleyball in 1972. In 1974, she became involved with the Central Washington Board of Officials where she served as an assigner for five years and was the chair of the By-Laws and Constitution Committee for two years. She has served as a trainer on two different occasions. Not only has Virginia been a part of officials committees at the local level, but she has also served at the state level as WOA Clinician along with her current role as the WIAA State 1A Volleyball Tournament Officials Coordinator.

Improvements Continue at Parker-Faller Field

When Daryl Parker proposed the re-naming of Parker Field in June, 2014, he stirred up new interest in the conditions and appearance of the ball park. It became a topic of discussion at Dick Smith's Baseballers lunches. Dick took action and a Parker Faller Field improvement Group was founded in September, 2014, with Rick Linneweh joining Dick as co-chair. The mission was to work with Yakima Valley Community College, Yakima Youth Baseball and Parker Youth & Sports Foundation to update and upgrade the Parker Faller baseball park to bring it up to the high standard of the surrounding campus, and for anticipated multiple uses by the college and community.

With PY&SF President Jon Mulvenon and directors Bob Alexander, Eric Carlson, and Bill Faller serving as members of the Field Improvement Group, the PY&SF Board approved the Group as an arm of the Foundation. Foundation director and treasurer Chuck Hinckley works directly with the Group as its treasurer. The Group has over twenty members with key participants in addition to those named above including Bob DiPietro, Bill Douglas, Bob Garretson, Kirk Gilday, Mel Moore, Keith Riffe, Morrie Shore, Bruce Staley, and Scott Wilson.

The field enhancement project is planned in three phases. This started with a badly needed redo of the playing field in the fall of 2014 and a renovation of the dugouts, donated by VK Powell. It included another field redo in the spring, partial painting of the stands and entrance ways, and a new Parker Faller Field sign on the back of the stands. Phase 1 was completed in July.

Phase II focused on a new main entry at the northwest corner. New wrought iron fencing and a main gate are completed and the area between the new fencing and gate has been covered with pavers. Also, the press box roof has been replaced by Yakima Youth Baseball with the work and materials donated by Leslie & Campbell and MG Wagner.

Phase III includes smaller parts of Phase II, including a Wall of Honor, and several major projects already given the go-ahead by the college. Work will be started on these this spring as the necessary funding is raised. The cost of completed work is in the \$150,000 ballpark and the planned projects cost will approach another \$100,000. YVCC is directly involved in upgrading the facility, moving ahead with plans to replace and upgrade the entire seating system at an estimated \$800,000. This is expected to be completed this spring.

The Field Improvement Group is proud of the field enhancements accomplished to date and greatly appreciate the many supporters and contributors who have made it possible. A special thank you to Bob Elkey, Scott Wagner, and Roger Campbell for donated labor and materials, to Scott Wilson for the design and construction of the new Parker Faller Field sign, and to major financial contributors Daryl and Sherrie Parker, Yakima Youth Baseball,the Fall-Brayton Endowment, Stan Renecker, Tom and Mary Herche, Denise and Gene Connor, and Phil and Pam Hinrichs. Many additional donations received are a significant part of the Group's total income and each one is much needed and appreciated.
